The Connétable explained that he had met the new licenced manager of the category 1 licence this week and he will be sworn in on Friday 25 February. He believes he will be an asset to the Seymour Inn and the Parish.

The Company secretary stood and explained that the category 3 licence applied for will be in addition to the category 1 that they already have. The plan is to serve meals to families until 9pm and stay open slightly longer on the very odd occasion until 1am. The company are making a large investment and will refurbish it fully. It will be like the Trinity Arms. They will close on Monday 28th February and re-open on 8th April 2022.

The Connétable thanked the Company Secretary for her explanation.

The Connétable asked if anyone would like to propose the Category 3 Licence. It was proposed by Steve Elson and seconded by Stanley Payn.

The Connétable wished every success to the team and was delighted to recommend a Category 3 licence to the Licencing Bench. It was noted that the various reports from the Parish Architect and Fire Service will be presented to the Royal Court once the refurbishment was under way. Full plans will also be submitted.
