Election of Centenier to complete a term of office expiring March 2026:	<p>Whereas by Act of the Royal Court dated the twenty third day of June 2023, an election was ordered by the said Court to be held in the Parish of Grouville to elect one person to the office of Centenier to complete a three year term expiring in March 2026.</p> <p>At this Assembly, one candidate to complete the term of office expiring March 2026 was duly proposed and seconded, namely:-</p> <p>Mr Paul Andrew Godel</p> <div><p>Proposer: Stanley William Payn Seconder: Adrian William Le Gal Andrew Boersma Jennifer Anne Bridge Nancy Freeman Janine Bosio Robert Vincent June Fosse Peter Falle</p></div> <p>Mr Paul Andrew Godel was duly declared elected to the office of Centenier for the said Parish of Grouville.</p>

	<p>The Connétable, having congratulated Mr Godel, warned him to attend the Royal Court of Jersey on 15 December 2023 to take the Oath of Office, subject to the agreement of the Bailliff and Autorisé.</p>
<p>Election of Centenier to fill a term of office expiring December 2026:</p>	<p>Whereas by Act of the Royal Court dated the thirteenth day of October 2023, an election was ordered by the said Court to be held in the Parish of Grouville to elect one person to the office of Centenier to fill a three year term expiring in December 2026.</p> <p>Nominations for the office of Centenier for a three year term of office expiring December 2026. As no candidates were nominated for the office of Centenier, representation will be made to the Royal Court to call for a further Nomination Meeting.</p> <p>Centenier Tessa Daniel whose term of office expires on 14 December 2023 was thanked by the Connétable for her loyal and dedicated service.</p> <p>No protests were made, and all formalities required by the Law were duly observed. The Assembly was attended by 15 Electors and closed at 18.41 hours.</p>
