**Minutes of the Roads Committee Meeting**

<b>1. Apologies</b>	Stanley Payn (SP)
<b>2. Approval of Minutes</b>	The minutes of the meeting held on Wednesday, 06 November 2024 were proposed by DBC and seconded by EG and duly adopted.
<b>3. Matters Arising</b>	
<b>3.1. Road Signs</b>	EG requested an update regarding the road signs that were agreed to be ordered at the previous meeting. ML advised that no signs have yet been ordered. After further discussion, the Roads Committee (RC) agreed to add La Rue Laurens to the list.  <b>ACTION POINT: ML to order road signs.</b>

<b>5. Recycling and Bring Banks</b>	ML advised that the Department for Infrastructure have been requested to delay the closure of bring banks around the island until the middle of 2025.  ML mentioned he is in the process of obtaining quotes for bring bank and kerbside recycling.

<b>6.1. Grouville Parish Church</b>	HG thanked ML for arranging the two disabled parking spaces outside the Parish Church.
<b>6.2. La Rue du Val Poucin</b>	EG advised that the drain at La Rue du Val Poucin has been cleared and it may need to be relined in the future.  <b>Helen left the meeting at 11:00.</b>
<b>6.3. La Rue de la Haye du Puits</b>	ML asked the RC to consider having a painted pavement on the left-hand side of Grouville School. The RC were all in favour.  <b>ACTION POINT: ML to contact the Head Teacher at Grouville School and the Department for Infrastructure.</b>
<b>6.4. Parish Accounts</b>	ML advised that he would like an extra page at the back of the Parish accounts in future, with an explanation sheet of the projects in the roads budget.
<b>6.5. Birds</b>	EG expressed his concerns regarding feral birds at La Cache des Pres and La Rue du Moulin de Bas and the potential outbreaks of flu. ML said he has been informed that the Environmental Department have advised feral birds can be culled should there be any outbreak.
