1. Apologies	Liz Sheehan

2. Dangerous Wall	CO warned the Roads Committee (RC) about a wall that appears to be collapsing on La Chevre Rue. The RC agreed to contact the landowner to advise them of the condition of the wall.	
3. La Rue du Moulin de Bas	ML advised that he has now arranged to have the willow hedge cut down to the ground. CO expressed his disappointment that the agreement with the landowners was made prior to final approval with the RC.	
4. La Rue es Philippes Drain	ML referred to item 6.1 of the minutes from 11 February 2025 and reiterated that the customary Voisinage Law stipulates that properties must have provision to accept water from properties that are located further up from them. The drainage issue at La Rue es Philippes was not created by the Parish. ACTION POINTS:	
	- ML to contact the landowner and request that they reinstate the drain that was blocked by the landowner.	
	- ML to contact the previous landowner who installed the drain.	
5. Streetlights	CO advised the RC that a letter has been sent to Andium Homes regarding the ownership of streetlights in the Parish.
