La Grande Route des Sablons	<p>The following was discussed regarding the upcoming roadworks on La Grande Route des Sablons:</p> <ul style="list-style-type: none">• Road works are scheduled to take place on La Grande Route des Sablons from La Rue de La Lourderie, on the Parish boundary, to just beyond the junction with La Rue du Puits Mahut, continuing just past the tower.• The road works will take place during the Easter half term holidays in 2026.• The works scheduled on La Grande Route des Sablons will be carried out in sections, with each section subject to a full 24/7 closure. Weekends have been included to allow the works to be completed as quickly as possible. Work will commence between 07:30 – 08:00 Monday to Friday and 09:00 over the weekend. The Government of Jersey (GOJ) Highways will work alongside the Parish to minimise disruption to refuse collections.• One-way systems are due to be implemented on Rue de Jambart and Rue de Causie in the Parish of St Clement.• GOJ Highways have been liaising with Liberty Bus with regards to proposed temporary diversion bus routes and shuttle buses were requested by Liberty Bus. <p>EG requested that banksmen are allocated on either end of Fauvic Crossroads due to it being quite a dangerous junction.</p> <p>GOJ Highways offered to arrange a drop-in session at Grouville Parish Hall for members of the public. The Roads Committee (RC) agreed that it would be beneficial.</p> <p>The RC raised concerns of potential speeding on one way diversion routes. ML said he will liaise with the Parish's Chef de Police.</p>

No concerns were raised regarding parking matters, visual splays or impact on road usage.</p> <p>No further concerns were reported.</p>
