Minutes of the Parish Assembly

Open Meeting	<p>The Connétable opened the meeting by welcoming everyone in attendance and pointed out the fire exits in the Parish Hall. The Connétable informed that the meeting will be recorded for the purpose of accurate minute taking and advised that anyone who wishes their name to be omitted from the minutes should inform him accordingly.</p> <p>The Connétable advised that votes taken this evening will be by a show of hands, however ballot papers have been handed out just in case they are required for items two and three of the agenda.</p> <p>The Connétable invited the Parish Secretary to read out the Convening Notice.</p>

1. To receive and, if deemed advisable, approve the minutes of the Parish Assembly held on Tuesday, 25 November 2025.	The minutes of the meeting held on Tuesday, 25 November 2025 were proposed by Leslie Norman and seconded by Eric Gavey. The Assembly voted and the minutes were approved unanimously.
2. To elect one Constable's Officer for the Vingtaine of des Marais.	<p>The Connétable asked for nominations for the role of Constable's Officer for the Vingtaine of des Marais.</p> <p>Adam Stone-Gomes was proposed by Drew Livingston and seconded by Tracy Laurent.</p> <p>Drew Livingston said Adam Stone-Gomes has lived in Jersey for two years and is very eager to be involved in the municipality and the community. Adam Stone-Gomes has had a career in financial crime and can speak fluent Portuguese, which will be very beneficial for the Honorary Police.</p> <p>No further nominations were received.</p> <p>As there were no further nominations, the Connétable declared Adam Stone-Gomes as Constable's Officer for the Vingtaine of des Marais and warned him to appear at the Royal Court at 09:45 on Friday, 19 December 2025.</p>
3. To elect two members of the Grouville Rates Assessment Committee for a term of three years.	<p>The Connétable asked for two nominations for the role of Rates Assessor.</p> <p>Two nominations were received, those being:</p> <ul style="list-style-type: none">- Adrian Le Gal, who was proposed by John Lamy and seconded by Andrew Koester.
