### **Minutes of the Roads Committee Meeting** **Held at Grouville Parish Hall on** **Monday, 23 March 2026 at 09:30**

<b>1. Apologies</b>	Rev. Helen Gunton.
<b>2. Approval of Minutes</b>	The minutes of the meeting held on Wednesday, 18 February 2026 were proposed by EG and seconded by SP and duly adopted.
<b>3. Matters Arising</b>	
<b>3.1. Draft Road and Vehicle Law</b>	SP requested it was minuted that DBC attended a meeting for a discussion regarding the roads law review, however, unfortunately as no member of the Roads Committee (RC) is available for the next meeting, comments have been shared to the Legislative Drafter in advance.
<b>4. Planning Applications</b>	<p>The RC inspected the following applications, focusing solely on potential impacts on roads:</p> <p><b>P/2026/10834</b> <b>P/2026/10797</b> <b>P/2026/10792</b> <b>RW/2026/10781</b> <b>P/2026/10752</b> <b>P/2026/10740</b> <b>P/2026/10705</b></p> <p>The RC referred to planning application P/2026/10834 and agreed to contact the Planning Department to advise that they have no concerns providing the entrance is not narrowed, which would affect visual splays.</p> <p>No further concerns were reported.</p>
<b>5. Scenic Lanes Competition 2026</b>	The RC agreed to enter La Rue du Champs into the 2026 Scenic Lanes Competition.
<b>6. La Rue des Alleurs Quarry</b>	<p>ML referred to concerns raised regarding the bank subsiding on to the road on La Rue des Alleurs by the entrance of the quarry.</p> <p>The landowner has confirmed that they will arrange to remove the top of the bank to reduce the weight. This will be undertaken at the same time the Parish carpark wall is repaired to avoid multiple road closures on La Rue des Alleurs.</p>
<b>7. AOB</b>	
<b>7.1. La Rue Vardon</b>	ML explained that over 10 years ago the Parish agreed to change Le Chemin au Greves from a two-way system to one way due to narrow width of the road, which made it a high risk for accidents. Because of this change, motorists have had to use La Rue Vardon which has led to an increase of maintenance on the

	privately owned road. ML has received a request to support the costs of maintaining the road, however confirmed he cannot do so without prior approval of a Parish Assembly. The RC agreed with ML.
<b>7.2. La Rue des Vaux</b>	DBC advised that La Rue des Vaux is in need of urgent repair due to damage caused by the most recent storm and heavy rainfall.
