Minutes of the Roads Committee Meeting **Held at Grouville Parish Hall on** **Wednesday, 20 May 2026 at 10:00**

1. Apologies	Helen Gunton and Stanley Payn.
2. Approval of Minutes	The minutes of the meeting held on Wednesday, 22 April 2026 were proposed by DBC and seconded by EG and duly adopted.
3. Matters Arising	
3.1. Speed Limit Review	ML reminded the Roads Committee (RC) that the deadline for completing and submitting the Government of Jersey Speed Limit Questionnaire was Friday, 15 May 2026.
4. Fosse es Russe	Following a concern received regarding current signage on Fosse es Russe, the RC agreed that as the road is a 'no through road' and the existing signage has not caused issues so far, the matter is considered a low priority. ML advised that he will contact residents on Fosse es Russe to seek their views. ML added that he is in the process of obtaining permission from a landowner to install a road name sign on La Sente des Fonds.
5. Jersey Rally 2026	ML advised that the organisers of the Jersey Rally have informed they will visit every household along their proposed route and any damage caused will be repaired by Jersey Rally. DBC suggested to ML that meetings held with Jersey Rally should be minuted going forward and the RC are happy to arrange meetings with Jersey Rally if required in future.
6. Planning Applications	The RC inspected the following applications, focusing solely on potential impacts on roads: P/2026/11085 RP/2026/11020 P/2026/11010 P/2026/10994 P/2026/10981 A/2026/10944 P/2026/10932 The RC highlighted concerns regarding the following applications: • P/2026/10994 – Concerns were raised due to the amount of water that cascades over the wall. The wall must be built to withstand water as best as possible. • P/2026/10981 – The RC are aware that New Road provides challenges for residents who wish to park their vehicles in the area.

7.1. La Rue du Moulin des Bas	Four contractors were approached for a quote for drainage works on La Rue du Moulin des Bas, however only one quote has been received so far.
7.2. Le Chemin au Greves	The RC agreed to allow property developers to install services by going through Le Chemin au Greves with the proviso that the entire road is resurfaced up to the Pro Shop. ML requested that it was minuted that the RC was surprised that the Bye Law stage was passed without services to the properties being available.
7.3. Le Grand Bourg Drainage	EG advised that the RC are waiting for an additional quote to have the drain at Le Grand Bourg repaired.
7.4. La Rue des Vaux	Two quotes have been received for road repairs on La Rue des Vaux. The RC agreed to accept the quote from Jersey Road Driveway Repairs (JR & DR Ltd).
