2. Approval of Minutes	The minutes of the meeting held on Wednesday, 17 June 2026 were proposed by EG and seconded by DBC and duly adopted.
3. Matters Arising	None.
4. Field G487	ML advised of a concern received regarding flooding emanating from field G487 into the Parish of St Clement. ML and the Roads Committee (RC) agreed to arrange a site visit, however ML referred to the customary Voisinage Law, which stipulates that properties/land must have provision to accept water from properties/land that are located further up from them.
5. Planning Applications	The RC inspected the following applications: RW/2026/11283 No concerns were reported.
6. La Hougue	ML and the RC agreed to grant Trinity Manor Farm and Albert Bartlett and Jersey Royal permission to defer their Branchage work, as young trees have recently been planted along the bank and cutting it back at this stage would likely result in the loss of the saplings. The RC noted, however, that the banks must be cut back before the next Branchage on Friday, 18 September 2026.

7.1. Potholes	DBC advised that the potholes along Le Boulivot de Bas are due to be repaired during the school holidays.
7.2. Budget	The RC advised that the following road projects which are a priority should be budgeted for with the approval of the Parish Assembly: - La Grand Bourg

9. Parish Roads	The meeting addressed the condition of roads in the Parish of Grouville and the following points were discussed: - Resurfacing at La Rue des Vaux will be taking place this financial year, with phase 2 hopefully commencing in the next financial year. - Concerns were raised regarding large potholes on La Rue Mauthrin, La Rue du Douettin and La Rue des Alleurs that require urgent attention. - ML confirmed that engineers are required to undertake work on La Rue du Moulin de Bas to stop the bank subsiding into the road. - New drains are due to be installed on Le Boulivot de Bas in the next financial year. - Drainage repairs are required on La Grand Bourg to alleviate flooding. - ML confirmed that the landowner of the gates on La Charriere du Bourg will be removing the gates as they are leaning into the road. - MWL expressed concerns of a boundary stone which sticks out of the road on La Route de la Francheville, though he is aware it is on a Government road. ML to contact the owner of the boundary stone. - ML mentioned he would like to place flood warning signs on La Cache des Pres.
